DATE & TIME: **January 6th at 9:00 AM** - (Race-Day Registration will begin at 7:30am)

LOCATION: The race will begin and finish at **The Back Porch Seafood & Oyster House in Destin - 1740 Old Scenic Highway 98, Destin, FL 32541**

FEE AND REGISTRATION: Entry fee is \$25.00 regular and \$23.00 for NWFTC members until Dec. 27th. Late entry fee is \$30 with no discount.

PACKET PICKUP: **Friday, January 5th from Noon - 6:00 pm at The Back Porch Seafood & Oyster House in Destin - 1740 Old Scenic Highway 98**
(Race-Day Packet Pickup will begin at 7:30am).

RACE COURSE: The out-and-back race starts and ends on the beach behind The Back Porch Restaurant. Race will proceed west to the jetties at the East Pass and return. **Distance is approximately 5.88 miles**, but will depend on the line taken. **This will be a "green" race so there will not be any cups at the water station. Runners will need to bring their own water bottles. Water will be available to refill your bottles along the route.**

AWARDS: Overall Male and Female, Overall Master Male and Female, and the Overall Grandmaster Male and Female. Three deep for male and female in these age groups 0-9, 10-14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75+. **Back Porch Jetty Run Beach Towels will be given to the first 100 registered runners.** Food and beverages will be available at the Back Porch Seafood & Oyster House post race party.

POST RACE PARTY AND AWARDS CEREMONY: Food and beverages, as well as the awards ceremony, will be held at The Back Porch following the race.
